#### STUDENT TUITION RECOVERY FUND (STRF)

According to BPPE's website: The STRF is a fund administered by the Bureau for Private Postsecondary Education (Bureau) that relieves or mitigates economic loss suffered by a student while enrolled in a qualifying institution – generally, one that is approved or registered by the Bureau. At the time of his or her enrollment, the student must have been a California resident or enrolled in a California residency program, prepaid tuition, and suffered economic loss.

Effective **April 1, 2024**, the Student Tuition Recovery Fund (STRF) assessment rate will change from two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges to zero dollar (\$0.00) per one thousand dollars (\$1,000) of institutional charges. #### Note: STRF is a NON-REFUNDABLE FEE.

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying

institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

(b) In addition to the statement required under subdivision (a) of this section, a qualifying institution shall include the following statement in its school catalog:

"It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- 1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
- 3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
- 7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF. A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written

application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

# **TUITION POLICY(s)**

All tuition and other program related costs are expected to be paid in advance prior to the beginning of the class. Any missed payments will need to be made current before the student can be allowed to resume coursework. All fees and costs are required to be paid in full prior to the completion of program and granting of a Certificate of Completion. This institution reserves the right to change the tuition and other program costs without prior notice. This institution

# **EXTENDED TRAINING**

#### RIGHT TO CANCEL

Assuming Jane Doe has paid upfront for the entire program (i.e., \$2,279). Jane Doe decides to cancel their program <u>after attending 6 classes</u>. Jane's refund calculation would look like this:

# **FACILITIES & EQUIPMENT**

<u>Santa Ana</u> - Students can utilize the stations equipped with LED lighting and outlets. This location is at about 4,200 square feet and can hold a minimum of 50 students, models, and staff at a time. Students have plenty of space to spread out their products and equipment such as brushes, palette/spatula, etc. Students are provided chairs to sit on, ring lights are placed around the room for additional lighting. Students are offered additional products to use during class from classroom supplies such as: (for MUA) eyeshadow palettes, eyeshadow primers, glitters, translucent powders, foundations, etc. Students are allowed to use the computer in the Student Media Center if they are interested in researching a particular look to practice or anything else school related. This campus is located right off the 5 freeway and 22 freeway,

perfectly nestled next to a busy plaza that offers varies eateries, coffee shop, gym and other stores.

<u>South Gate</u> – Students can utilize the stations equipped with LED lighting. This location is at about 1200 square feet and can hold up to 20 students, models, and staff at a time. Students have plenty of space to spread out their products and equipment such as brushes, palette/spatula, etc. Students are provided chairs to sit on, ring lights are placed around the 42

room for additional lighting. Students are offered additional products to use during class from classroom supplies such as: (for Eyelash Extensions) bed to practice on live models, LED headsets for magnification, additional types of lash trays, eyelash wash, barbicide and other sanitation supplies etc. Students are allowed to use their phones with free school wifi if they are interested in researching a particular look to practice or anything else school related. The school is close to the 710 Freeway, on Tweedy Blvd, across the street from the 99Cents Store; major cross streets include Atlantic and Tweedy Blvd.
